Introduction to GetSetGrow








Market Watch



- Market watch screen is default screen available on the Home page.
- A Security or Contracts of other exchanges is added to market watch by clicking "Instruments" entering scrip name in "Search" option with options like All, Stocks, Futures and Options.
- The search security or contract can be added to market watch by clicking "+"button next to symbol name.
- Following functions are invoked by selecting a security or contract from market watch:
- Buy Order Entry
- Sell Order Entry
- Security Info
- Market Depth
- Delete Scrip



- Prev Close




Charts



- If Chart window is open and user select scrip from Market watch, Chart will get loaded for that particular symbol.
- Chart displays the price movement of selected security or contract during trading hours.
- The Chart can be viewed in various Types:
- Candle Stick
- Line
- Area
- Bar
- Hollow Candles
- Heikin Ashi
- Baseline
- User can set candle timing as below
- User can select multiple Indicators
- User can also select multiple charting tools from right side of chart



Place Order




- Click on "Buy or Sell" button to execute the order.
- Buy Order Entry Window
- On submitting the order, a confirmation of order is displayed on the screen.
- All orders placed are passed through the Risk Management System (RMS) to check the order and exposure parameters against the limits set by member broker.
- Order is executed only after RMS validation is done. If order is not validated, the same is rejected and appropriate message is reflected for the same. Rejection message is reflected in order book or log messages.


Order Book



- Order Book will be displayed in lower part of home page in tabbed.
- The order book lists current orders and their status.
- Order Details of the selected security or contract is viewed by clicking on order details icon from "Action column" for each order.
- Order history of the selected security or contract is viewed by clicking on order history icon from "Action column" for each order.
- Order is cancelled or modified by selecting the desired security or contract and clicking on Modify Order icon and Cancel Order icon from "Action column" respectively.
- User can modify Order Type, Validity, Price, Quantity and Disclosed Quantity, Trigger Price, of an order.



Trade Book




- Trade Book will be displayed in lower part of home page in tabbed.
- Trade book screen displays all executed orders at exchange during the trading day.
- All columns of Trade book can be sorted as per the client's requirement.
- User can export data of Trade book and view / save in CSV or PDF format.
- User can click on "Trade Details" icon for each trade and can see more details
- User can click on "Trade Details History" icon for each trade and can see trade fill history details
- User can also pin / unpin specific column


Position



- This feature provides to view real-time positions for trading day.

- User can select detail view icon to see more details




Holdings

- To place a withdrawal request click on Withdraw Funds


